# 2024 Sip 'w' Shop and SILENT AUCTION 50/50 RAFFLE OFFICIAL RULES AND TERMS AND CONDITIONS

By purchasing a 50/50 Raffle Ticket, you are agreeing to comply with all Terms and Conditions of these Official Rules, and winning is contingent upon fulfilling all requirements.

## Promotion Description:

The Georgetown Public Library 2024 Sip 'n' Shop and Silent Auction 50/50 Raffle will grant one lucky winner 50% of the 50/50 Raffle ticket sales received between August 30, 2024, and October 11, 2024 at 7:30pm ET.

The winning ticket (and winner) will be randomly selected at the 2024 Sip 'n' Shop and Silent Auction at the Georgetown Public Library, 123 West Pine St, Georgetown, DE 19947.

## Eligibility:

To be eligible you must be at least 18 years old. To enter the 50/50 Raffle, a person must hold at least one raffle ticket but may enter the drawing with multiple tickets. A ticket purchased by an ineligible person is void and cannot be a winning ticket.

Cash purchases only.

#### Official Prize:


The prize for this raffle is 50% of the 50/50 Raffle ticket sales received between August 30, 2024, and October 11, 2024 at 7:30pm ET.

#### Winner Selection:

The 50/50 Raffle will end on October 11, 2024, 7:30 pm ET. The winner will be announced soon after the raffle ends. The winner will be chosen in a random drawing and will be notified by phone and email, if not present at the event.

## Verification of Winner:

All potential winners are subject to verification by the Friends and Board of Commissioners of the Georgetown Public Library whose decisions are final and binding in all matters related to the 50/50 Raffle. An entrant is not a winner, unless and until entrant's eligibility has been verified and entrant has been notified that verification is complete.

Original 50/50 Raffle ticket <u>with matching winning ticket number</u> must be presented to claim prize. Raffle tickets are nontransferable. 50/50 Raffle tickets are not valid if altered or photocopied. The Georgetown Public Library (GPL) and the Friends of the GPL cannot be responsible for lost or stolen 50/50 Raffle tickets.

The potential winner will be notified by email and phone as provided on the ticket stub. The prize winner will be required to sign that they were disbursed the winning funds and that they understand that they must comply with any tax reporting as required by law (except where prohibited).

If a potential winner of the prize cannot be contacted, or fails to claim prize by 10/25/24, 3:00pm ET, such potential winner forfeits the prize. In the event the prize winner is disqualified, an alternate winner will be drawn by random drawing among all remaining eligible entries.

### Release:

By receipt of any prize, winner agrees to release and hold harmless the Friends of the Georgetown Public Library and Georgetown Public Library and their respective subsidiary, and affiliate companies, supplies, distributors, and advertising/promotion agencies, as well as each such company's officers, directors, employees, and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the 50/50 Raffle or receipt, use, or misuse of any prize.

# Privacy:

Except where prohibited, participation in the 50/50 Raffle constitutes winner's consent to the Friends of the Georgetown Public Library, Georgetown Public Library, and its agents use of winner's name, likeness, photograph, voice, opinion, and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration. The winner's name will be announced publicly unless the winner requests in writing that they wish their name to be kept private.

## **General Conditions:**

The Friends of the Georgetown Public Library and Georgetown Public Library reserve the right to cancel, suspend and/or modify the 50/50 Raffle, or any part of it, if any fraud, or other factor beyond the reasonable control of the Friends of the Georgetown Public Library and Georgetown Public Library impairs the integrity or proper functioning of the 50/50 Raffle, as determined by The Friends of the Georgetown Public Library and Georgetown Public Library in their sole discretion. In such an event, the Friends of the Georgetown Public Library and Georgetown Public Library reserves the right to award the prize at random from among eligible entries received up to the time of the impairment. The Friends of the Georgetown Public Library and Georgetown Public Library reserve the right, in their sole discretion to disqualify any individual, without compensation, it finds to be tampering with the entry process or

the operation of the 50/50 Raffle or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the 50/50

Raffle may be a violation of criminal and civil law, and should such an attempt be made, The Friends of the Georgetown Public Library and Georgetown Public Library reserves the right to seek damages from any such person to the fullest extent permitted by law. The Friends of the Georgetown Public Library and Georgetown Public Library's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. All necessary travel arrangements are the sole responsibility of the winner.

### Limitation of Liability:

The Released Parties are not liable for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors, or by any of the equipment or programming associated with or utilized in the 50/50 Raffle; (2) unauthorized human intervention in any part of the entry process of the 50/50 Raffle; (3) technical or human error which may occur in the administration of the 50/50 Raffle or the processing of entries; or (4) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the 50/50 Raffle or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the 50/50 Raffle.

# Disputes:

Except where prohibited, entrant agrees that: (1) any and all disputes, claims, and causes of action arising out of or connected with this 50/50 Raffle or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by a state or federal court located in Georgetown, Delaware; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this 50/50 Raffle, but in no event attorney's fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant claims all rights to claim, indirect, punitive, incidental, and consequential damages and any other damages and any other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and the Friends of the Georgetown Public Library and Georgetown Public Library in connection with the Raffle, shall be governed by, and construed in accordance with, the laws of the State of Delaware, without giving effect to any choice of law or conflict of law rules (whether of the State of Delaware or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Delaware.
